the initial conversion rate that one (1) 2015 Preference Share to two (2) ordinary shares according to the terms of the
2015 Preference Shares, 755,451,262 ordinary shares will be issued on the assumption of full conversion of the
remaining 2015 Preference Shares at the close of March 2020.
